Update your renewed Trade License with the bank

As per the UAE Central Bank regulation, Banks are required to retain a copy of the Valid Trade License of all the Companies maintaining accounts with them.

In case valid Trade License is not submitted for more than 90 days after expiry, charges will be recovered from the account each month until a valid Trade License has been submitted to the Bank.
